Purpose

Coronavirus (COVID-19) is classified as a pandemic and is affecting lives and work around the globe. We want you to know what we are doing as a company to protect you and your families and mitigate the spread of this illness. This subject will explain these measures and how you can assist us in our efforts to promote a safe and healthy environment both at work and at home.

This policy applies to all employees regardless of where or in what capacity they work.

2. What is Coronavirus?

Per the World Health Organization (WHO), Coronaviruses are a large family of viruses that cause illness ranging from the common cold to more severe diseases such as Middle East Respiratory Syndrome and Severe Acute Respiratory Syndrome. A novel coronavirus is a new strain that has not been previously identified in humans.

Coronaviruses are zoonotic, meaning they are transmitted between animals and people. Common signs of infection include respiratory symptoms, fever, cough, shortness of breath and breathing difficulties. In more severe cases, infection can cause pneumonia, severe acute respiratory syndrome, kidney failure and even death.

Standard recommendations to prevent infection spread include regular hand washing, covering mouth and nose when coughing and sneezing, thoroughly cooking meat and eggs. Avoid close contact with anyone showing symptoms of respiratory illness such as coughing and sneezing.

COVID-19 affects different people in different ways. Most infected people will develop mild to moderate illness and recover without hospitalization. The most common symptoms:

- Fever.
- Dry cough.
- Loss of taste and smell

3. Prevention & Protection against Coronavirus

The following required actions should be observed by all employees in order to protect themselves and others from Coronavirus. To prevent infection and to slow transmission of COVID-19, do the following:

- Wash your hands regularly with soap and water for 20 seconds, or clean them with alcohol-based hand rub.
- Maintain at least 2 metre distance between you and people.
- Avoid touching your face.
- Cover your mouth and nose when coughing or sneezing.
- Stay home if you feel unwell.
- Refrain from smoking and other activities that weaken the lungs.
- Practice physical distancing by avoiding unnecessary travel and staying away from large groups of people.

The workplace mandatory procedures for the site are:



- 2 meters distance to be kept from other employees
- A face mask must be worn at all times when leaving departments and going around site
- Wash hands for 20 seconds or sanitise hands regularly
- Adhere to COVID risk assessment procedures

Illness

- Employees who are sick especially with cold or flu symptoms such as coughing, sneezing, or fever should remain home and seek medical attention or coronavirus test immediately.
- Employees with sick household members should stay home until a household member has been tested negative for Coronavirus.
- If an employee becomes or shows symptoms at work, they will be separated from other employees and sent home to get a test performed.

Work from Home

- If an outbreak becomes severe enough, a mandatory "Work from Home" procedure may be put into effect for personnel who can work from home. This will continue until conditions improve well within healthy limits per local health and/or governmental bodies.
- If an employee needs to care for a family member who has been diagnosed with COVID-19, they will be required to work from home for at least 10 days after the family member has tested positive or started showing symptoms.

Travel

- Travel restrictions will be maintained and monitored by the directors. General rule at the moment is All work trips and events both domestic and international will be cancelled/postponed until further notice.
- If an outbreak becomes severe enough, employee travel may be partially or fully restricted until conditions improve.
- We will leverage the use of virtual meeting technologies to continue work that would normally be conducted onsite.
- If an employee has recently returned from any area with a high number of COVID-19 diagnoses, they will be required to work from home for at least 10 calendar days and may return to the office if no symptoms have presented themselves.

Outside of Work

• Personnel from work or the personnel household members found to breaking local or national COVID regulations outside of work may be asked to self-isolate for 5 days and not return to work until a negative tests has been determined after the 5 days. Proof of negative test will need to be given to your immediate management.

If you or a household member have been diagnosed with Coronavirus

If an employee or an employee's household member has been diagnosed with COVID-19, they may not return to the work until after full recovery has been confirmed by a medical professional. No exceptions.

We recognise that a diagnosis does not mean an employee is unable to work. Therefore, until full recovery is confirmed, if the employee is able to work, they may do so from home, per approval of their immediate manager.
